CEMETERY RECORDS

Coweta County Cemetery Records (Georgia Genealogical Society Quarterly, Vol. 14, no. 3, Fall 1978):

Primitive Baptist Church cemetery

Directions: North on U.S. highway 29 north of Newnan approximately 2 & 4/10 miles north of Newnan city limits; turn left on County road S 2018 and continue approximately 1 mile to Happy Valley Road on the left, turn left and go approximately 4/10 mile to the cemetery site in a wooded area on the left (south) side of the road. 1/10 mile before the road forks near Happy Valley Church. The GPS location of the grave of Martha (Herring) Upshaw grave is N33-26.209, W084-46.644. (Note: there is evidence of several graves found in about a fifty foot area, but only three markers, lying face up on the ground, are found, first copied in 1977 by Ted O. Brooke).

At the cemetery site, two above-ground stone cairns (uninscribed) are visible; the marked graves of Moses W. Stamps and Sarah Redwine Stamps are twenty feet west of these and the grave of Martha (Herring) Upshaw is twenty feet west of these. All three markers are fallen, lying flat on the ground and covered with leaves and usually not visible, which has probably contributed to their survival for this long.

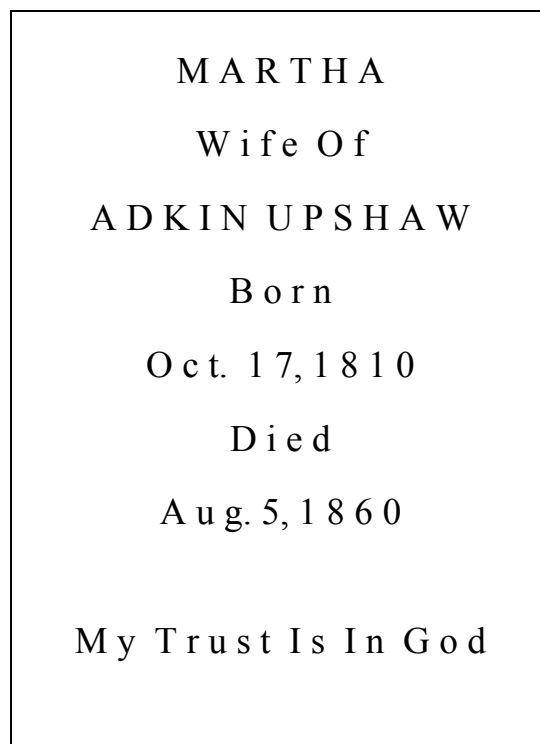

When a young man he left the farm to seek his fortune in Atlanta, Georgia, then little more than a village. There he entered the mercantile business. While boarding in the home of Mr. I.D. Upshaw, he met Mrs. Upshaw's niece, Georgia Kansas Moseley, and immediately fell in love with her. After a short courtship they were married October 3, 1875, at the home of Mr. Upshaw.

Page 66: Moseleys.

Georgia Kansas Moseley was born in Carroll County, near the Chattahoochee River. After the death of her parents she made her home with her relatives in Georgia and Alabama, attending school in both states.

While making her home with her aunt and uncle, Mr. and Mrs. I.D. Upshaw, in Atlanta, Georgia, she met and was courted by James Brown, which culminated in their happy marriage, Oct. 3, 1875, at the Upshaw home, 82 South Forsyth Street. Mr. William Butts officiated in the presence of friends and relatives. They spent all of their long, happy married life in Atlanta.

Page 70: A Short Sketch of the life of Joseph Witt Moseley Ferguson.

The war closed in 1865 and my mother's sister's family, Uncle John and Aunt Eliza Upshaw and their three children, spent a few months with us. They then moved to Alabama and it was a long time before we saw them again.

Page 86-87: Stamps Family.

Moses Witt Stamps was born April 9, 1803, on his father's plantation in Jackson County, where he spent his boyhood, then going to Coweta County when his family moved there. In those pioneer days when this country was so sparsely settled, the young men rode many miles on horseback to court the girls of their choice. Moses Witt Stamps made the long trip from Coweta County back to Jackson County to court beautiful auburn-haired Sarah Freeman, whom he married December 5, 1826, taking her to his home in Coweta County. They lived in that part of Coweta County which was taken off to form Campbell County, where he was a Justice of the Peace in 1834 and for some years after, moving back to Coweta County later. He was a planter of some means, but his health failed in the prime of life and his wife, Sarah, managed the large plantation. Therefore, at his death, April 18, 1853, she was able to carry on the work very profitably. She married Jacob Redwine a few years later and according to Moses' will the property was divided among the children. Moses Stamps is buried in a Primitive Baptist churchyard near Newnan where his wife, Sarah, was laid by his side at her death, October 14, 1881. The church is now gone and the graves are in a field.

Page 93: Relatives in Religious Work:

William David Upshaw, born Oct. 15, 1866, son of Charity Adeline Stamps and her husband, Isaac David Upshaw, when a young boy, fell on a wagon when hauling wood, injuring his spine, on account of which he lay on the bed seven years and for the rest of his life has worn a plaster cast and used crutches. But his affliction did not deter him in his ambition. After he could go about, he entered Mercer University at Macon, Georgia where he graduated in a very short time. He has been a strong advocate of the temperance cause, going all over the country lecturing for prohibition. In the year 1919 he was elected to the United States Congress from the 5th District of Georgia, where he served four terms until 1927. During this time he was a spectacular figure, championing the right at all times, regardless of public opinion. That he was an unreconstructed Rebel was always something he took pride in proclaiming. Her was a staunch Baptist and devout Christian. After his terms in Congress were over he was in demand as a lecturer all over the country on varied subjects, but particularly prohibition. He was ordained a Baptist preacher in April, 1939. The following is an account of his injury as he tells it in his book "Echoes from a Recluse":

"On the misty morning of February 18, 1885, while a happy farmer boy, I was hauling timber on an open wagon frame. After unloading , with the thought 'this work must be finished today' I sprang hurriedly into the wagon. The team started suddenly. I lost my foothold and fell backward, striking my spine on a cross piece of the frame. Apprehending little trouble (as I felt little pain) I walked home a half mile. I was in bed a day or two and was able to walk about the house and yard for seven months before going to bed."

John Thomas Brown, born 31 January 1846, died 17 February 1914, married first, Minerva Farmer on 4 January 1866. She died later that year. He married second, 22 February 1871, to Jennie Sara Toy of Atlanta, died 15 July 1903; they had 11 children. Their first child was James William Brown, born 22 October 1871, died 22 December 1923, married 1894 to Maude Upshaw.

Page 292: Family Histories: Keith

In the spring of 1884 the three sons of James Jackson Keith of Meriwether County moved to Newnan: Nathaniel Lawrence (Boss) born 1853, died 1891; Milton G. (Tat) born 1856, died 1929; and James Jackson (Jack) born 1863, died 1918. Jack and Tat operated a livery stable on the southeast corner of Madison and Jackson Streets, Boss operated a saloon on Greenville Street near the southwest corner of Spring Street. Nathaniel Keith bought the A.R. Word home at 22 East Washington Street, which was next door to Burdette's Cotton Warehouse on the corner.

A. Nathaniel Keith married Durah Upshaw and had two children: Mattie Keith born 1881, died 1956; and Lawrence William Keith, born 1883, died 1971. Both children born in Meriwether County. When their mother, Durah Upshaw Keith, died in 1883, their Uncle Jack raised them. Lawrence attended Georgia Military Academy in College Park and Newnan Telegraphy School. He worked for Central of Georgia Railroad.

Ten children, three died in infancy, one daughter, Catherine Todd, born in Coweta Co. 6-30-1908.

Ray Upshaw Todd born 4-4-1906 in Fayetteville, died 8-9-1978, son of Mainyard and Ida Valentine Todd. Married on 6-18-1936 to Maline Juanita Howard born 3-1-1912 in Cedartown, died 8-10-1967. Ray attended Oglethorpe University and for most of his life worked as a printer for *The Newnan Times-Herald*.

Martha Todd born 4-19-1946, daughter of Ray Upshaw and Maline Howard Todd of Cedartown. Has been a teacher since 1968, teaching at Jonesboro Senior High School and the Coweta County schools. Married George Jay Abelt born 5-18-1946, son of Fred and Lillian Webb Abelt. He was a funeral director for Hillcrest Chapel and now works for the Fulton County Police Department. One child: Jennifer Kathryn born 10-16-1971 in Newnan. Attends Central High School, is in the Honors Program, the band, and is the editor of the *Georgia Peach*, the state newsletter for the Children of the Confederacy.

Married, first, Martha Herring, born 1809, died 1865 in Coweta, in 1825 in Walton County.

Their son, Robert Valentine Upshaw, born 1845 in Coweta Co., enlisted in the Confederate Army for the first time in Newnan. He was captured by the Union forces but was released in an exchange of prisoners, and reenlisted in Meriwether Co. Married 9-22-1871 to Ida Pope Rowton, born in Carroll Co. He died in Shawnee, OK, date unknown. She died in Carroll Co.

Ten Air Force reservists called to active duty this spring in the wake of the Pueblo incident were killed Sunday in the crash of a C124 Globemaster in the Brazilian jungles.

Among them was the Commander of the aircraft, Captain Emory L. Upshaw, Jr., of 6700 Roswell Road, Sandy Springs, formerly of Newnan.

The 37 year old Newnan native was married to the former Susan Addy, also a native of Newnan,, who survives him. He is also survived by an eight year old son, Alan; his parents, Mr. and Mrs. E.L. Upshaw, Newnan and a sister, Mrs. Marvin Cole, Sharpsburg.

Mrs. Upshaw and son, Alan, were visiting her parents, Mr. and Mrs. George Addy, here in Newnan when informed of the tragedy early Monday morning.

Memorial services for the victims', most of whom were from the Metropolitan Atlanta area, were held Wednesday morning at Dobbins Air Force Base.

The plane was part of the 700th Military Airlift Squadron of the 445th Military Airlift Wing at Dobbins.

The crew was called to active duty last January at the height of the Pueblo crisis. Most of its members were from the Atlanta area.

Captain and Mrs. Upshaw and son were living in Newnan at the time he was called and he was employed by Sears, Roebuck and Company in Atlanta in the Personnel Department. After being called to active duty, they moved to Sandy Springs to be nearer the Dobbins base.

He was graduated from Newnan High School and was later graduated with honors from Georgia Tech.

Officials at Dobbins said that the plane apparently crashed around 8:00 p.m. Sunday.

The wreckage of the plane was found near Inbuzeiro, Brazil. There were no survivors among the ten crew members on board.

The plane was en route from Zanderig Airport, Surinam, to Recife, Brazil, on a military airlift mission.

The Globemaster had departed Zanderig airport at 11:30 a.m. Sunday and was scheduled to arrive in Recife at 9:00 p.m. Surinam, or Dutch Guiana, is on the northeastern coast of South America. Recife is a major Brazilian port on the northeastern tip of Brazil.

Air Force officials say the last radio transmission from the plane was received five minutes before the Globemaster was scheduled to land. (continued on page 2,

This short notice will recall to many of the older residents of Coweta and adjoining counties the boyhood and young manhood of Rev. A.G. Upshaw. Some perhaps were comrades in war – others schoolmates. More many (sic) remember him in the pulpit. Though deprived of his right arm, which he lost in battle, he was still active until a few years ago, when, on account of feeble health and advancing years, he was forced to withdraw from active work. He made his home with his daughter – Mrs. J.W. Brown at Decatur, Ga., where he passed away on April 18 – aged 75. He is also survived by another daughter, Mrs. J.R. Wise, of Madras, and four sons, M. Paul Upshaw, R.A. Upshaw, C.G. Upshaw and George Forrest Upshaw.. His body was brought to Madras and interred in the cemetery at Jones Chapel on April 19.

20 February 1920:
